With reference to the above cited subject, as per ref (1) Renewal Fire safety Compliance report was issued by the District Fire Officer, Hulimavu Fire Station to the educational premises of M/s PSBB Learning Leadership Academy, No.52, Laxmipura, Sahasra Deepika Road, Off Bannerghatta Road, Sakalvara Post, Bangalore 560083.

With reference cited ref (2) above the management M/s PSBB Learning Leadership Academy, had requested for the renew the renewal fire safety compliance report from our department. In this regard the above addressed educational building was inspected by Fire Station Officer, Hulimavu Fire Station on 11-07-2025 for the issue of renewing the renewal fire safety compliance report. And as per ref (3) submitted the report to issue of renewing the renewal fire safety compliance report.

Under the above circumstance the Karnataka Fire & Emergency Services Department is renewing the <u>"Renewal Fire Safety Compliance Report"</u> to the educational premises of M/s PSBB Learning Leadership Academy, No.52, Laxmipura, Sahasra Deepika Road, Off Bannerghatta Road, Sakalvara Post, Bangalore 560083. Subjected to proper maintenance of fire—fighting installations in the good working conditions and must arrange for 40% of staff/employees training in the fire prevention and fire fighting measure at R.A.Mundkur fire and emergency services academy within the 03 months from date of issue of this certificate.

In case the Fire prevention and Fire fighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, this renewal Fire Safety Compliance Report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of Chemicals, Solvents, Petroleum products (Diesel/Petrol), LPG, etc in the premises/building. This Renewal fire safety compliance is issued from the fire prevention and fire fighting point of view, The Karnataka State Fire and Emergency Services Department is not responsible for the ownership of the land, its location and other disputes, which may arise in due course.
