- That in all necessary aspects, the sanitation is good.


The Sanitary Certificate is issued Subject to the following conditions:

- If anyone suffering from fever, cold, cough and difficulty in breathing, it should be informed to the local health authority.
- The establishment should ban Cigarette and other tobacco products in the campus and visible 'No Smoking' board should be displayed as per COTPA ACT 2003.
- Unnecessary containers or things should be disposed to frequently to avoid **mosquito breeding** for the prevention and control of vector borne diseases.
- The number of urinals / toilets should be increased according to staff's and student's strength.
- Child labour should not be engaged.
- Occurrence of any contagious disease should be informed to the Undersigned to take necessary action.
